This is in continuation of the visit of the UGC Visiting Committee to consider the XI Plan General Development Grant Allocation to your University.

2. Based on the Report submitted by the XI Plan UGC Visiting Committee and availability of funds from the Government of India, UGC has approved the tentative XI Plan Allocation, subject to availability of funds from Government of India, in respect of your University as under:

	(Rs. in Lakhs)
i) General Development Grant	750.00
ii) Merged Schemes	578.50
iii) Internal Quality assurance cell	5.00

3. The 'on account' grant already under the above schemes released by UGC during XI Plan Period will be a part of XI Plan Allocation of the university. Further, funds for Merged Schemes is based on the eligibility criteria indicated in the XI Plan Guidelines. Therefore, the grant for each of the merged scheme will be released subject to the fulfillment of the eligibility criteria and other related norms as laid down for the purpose.
4. A new scheme called Internal Quality Assurance Cell has also been included in the merged schemes and an additional amount of Rs.5.00 lakhs has been allocated to each State University. The Guidelines of this Scheme may be seen on UGC website www.ugc.ac.in
5. The XI Plan Allocation is subject to compliance of the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 30<sup>th</sup> March/21<sup>st</sup> April, 2009 which is also available on UGC website www.ugc.ac.in.
6. In addition to above, the following Administrative Reforms may also be implemented:
- Implementation of the Govt. of India Reservation Policy of SC/ST.
  - All Statutory posts should be filled up the appointment through Selection Committee as per the UGC Regulations.
  - All vacant Teaching Posts should be filled up expeditiously.
  - Annual Accounts, Annual Reports and Quality assessment Status Report should be submitted in time i.e. by 31<sup>st</sup> December of every year.
7. The release of grant will also be linked to Academic and Administrative Reforms as well as compliance of various policies of Government of India rules.
8. You are also requested to utilize proportionate grant on half yearly basis. Any portion which remain unutilized will be considered to be lapsed. UGC will also consider to

allocate the unutilized grant of the university to other universities which are better performing and are also following the various academic reforms as well as implementation of various policies of Government of India. Therefore, the University is advised to utilize the grant fully.

9. The amount recommended by the Visiting Committee for various merged schemes may be utilized as per guidelines of respective schemes available on UGC website. The anomaly if any as per pattern of assistance/guidelines may be brought to the notice of the Commission.
10. You are, therefore requested to re-work the priorities of university within the General Development Grant allocation as decided by the Commission and keeping in view the recommendation of the Visiting Committee. The revised proposal (item-wise and year-wise plan) in the prescribed format UGC (copy enclosed) may be sent within 15 days in duplicate along with the soft copy within the ceiling conveyed to University. After receipt of the item-wise allocation within the amount as decided by the Committee, the UGC will convey the final approval of XI Plan Allocation to the University.
11. A copy of the Report of the Visiting Committee is enclosed herewith for further necessary action at the University level.

Established in 1927, Agra University was functioning as an affiliating University for a long time until teaching institutes and the departments were setup at the campus in 1953. It was with the establishment of KM Institute of Languages and Institute of Social Sciences in 1953 that the University acquired the residential character. Its jurisdiction was extended to cover United Province of Agra and Oudh, Central India and Rajputana. In due course of time and with the expansion of higher education, 13 different Universities have been carved out of this University.

At present, 11 institutes / schools and 8 independent teaching departments are engaged in academic activities in the campus and the number of students is increasing year by year. Presently more than 300 colleges are affiliated and recognized by the University. The University is spread over four scattered campuses namely Paliwal Park, Khandari, Chhelesar and Khandelwal Kothi it imparts education at several levels and runs regular as well as self financing courses.

In the past many distinguished personalities had been associated with the University, prominent among them being Dr. Shanker Dayal Sharma, Pt. Moti Lal Nehru, Sir Tej Bahadur Sapru, Justice Gopal Swaroop Pathak, Sri. Guljari Lal Nanda, Ch. Charan Singh, Pt. K.D. Paliwal, Pt. Hridya Nath Kunjru who were instrumental in bringing above a number of reforms at the University.

This session was attended by all the Deans, Heads of the Departments, Registrar and other officials.

Prof. K. Ramamurthy Naidu, Convener of the Committee congratulated the Vice-Chancellor for his excellent presentation and appreciated the efforts made by the University so far. He also outlined the objectives of the visit of the expert committee.

Dr. Gurbaksh Singh, Member Secretary of the committee, briefed about various schemes for which allocation is to be made. He also explained provisions and eligibility conditions which are to be fulfilled by the University for financial support under a particular scheme.

After the Introductory session, based on the expertise the members of the UGC Committee were divided into two groups for their expertise to visiting various departments and central facilities:

The Committee also held several rounds of discussions and made department wise recommendations on the basis of priority and justification given by the University.

The Committee held interactive sessions On the second day, with the students, teaching and non-teaching staff of the University.

At the end of the visit, the committee had an exit session with the Vice-Chancellor on 19<sup>th</sup> June 2009. The Convener thanked the Vice-Chancellor, officers and the faculty members for extending their whole-hearted support during this visit. The Committee has made some suggestions for further strengthening of the academic activities and over all development of the University. Dr. Gurbaksh Singh, Member Secretary of the Committee thanked all the members of the visiting committee as well as Dr. B. R. Ambedkar University for their cooperation and support in accomplishing the task assigned by the UGC.
