Sir/Madam,


This has reference to your letter no. MANUU/VCC/MAP/DPE/2015/09 dated 26.11.2015. In this regard, I am directed to inform you that the Distance Education Committee of UGC in its meeting held on 18.11.2015, considered the fact that the programme which were recommended by the Expert Committee, which visited the university in September 2011 but the approval of the said programmes was not accorded as the programmes were not being offered through regular mode. Now, the university vide its letter no. MANUU/DDE/2015/1455 dated 08.09.2015 has informed that the above programmes are being offered through regular mode (copy enclosed).

2. The Distance Education Committee of UGC decided to allow the univeristy to offer 5 programmes i.e (i) B.A. (ii) B.Sc (PCM) (iii) B.Sc (CBZ) (iv) M.A and (v) B.Ed programmes through distance mode prospectively and further recommended that the B.Ed programme should be launched only after the approval of the NCTE during the year 2015-16. This is in addition to approval conveyed to your University for offering programmes under distance learning mode during the session 2015-16, vide UGC letter no. **UGC/DEB/1/3/MANNU/2015/101** dated 07th October, 2015.

3. It may also be noted that the ex post facto approval cannot be accorded in view of the report of Prof. Madhav Menon and the observations of the Hon'ble Supreme Court in the case of Annamalai University, wherein ex post facto recognition was not permitted.

4. The university shall scrupulously abide by the all terms and conditions, while offering the programmes through distance learning mode during the session 2015-16 in accordance with the Affidavit dated 26.06.2015, duly notarised and signed by Shri S.M. Rahmatullah, Registrar of the university, submitted to the commission vide letter dated 25.06.2015. The university is also required to send a list of programmes which are being offered during 2015-16 academic session.


